#### **4900** Agenda item 4:- Matters to report.

The clerk explained that the council received several grant applications since the finance meeting. He explained that the Community Council has received applications from the following groups.

Cllr Tilley declared a personal interest in the Llandenny application but remained in the meeting.

One member asked about the grants for the local graveyards. It was explained that the Community Council receives applications from groups that maintain and service the management of such projects.

A discussion took place with a range of views being discussed; it was:

**Proposed** by Cllr Dorey **seconded** by Cllr Bevan the two grants are accepted. All those present agreed.

Under this heading the Chairman raised the issue relating to the repair of the bus shelter in Raglan Village. The Chair explained that the remedial works were undertaken by Monmouthshire County Council and the Community Council had no need to contribute. Members welcomed the news.

The Clerk explained that no member/s have expressed an interest in the vacant position on the Raglan School governing body since the last meeting.

After some discussion Cllr Martine Dorey expressed an interest in the position. It was: Proposed that Cllr Dorey represent the Community Council on the Governing body and the Clerk informs the head teacher.

The chairman explained that the Community Council has received details of a number of Planning applications over the last number of months from the Clerk. He also explained that the Community Council has received several emails relating to the Common Land at Treworgan Common. Cllr Tilley asked for an update on the current situation. The Clerk gave those present a short update on the current situation, and this was noted.

#### **4902** Agenda item 5:- Reports from the County Councillor

Cllr Jones gave members a verbal report on several topics. The topics related to the following.

Cllr Eilertsen declared an interest as serving on the Management committee of the RVHA

Cllr Jones also expressed concern over the number of scams that are going around, including the scam relating to the Census and residents being told that they will be fined.

Cllr Jones also explained about Covid 19 in Monmouthshire which appears to be in a good place currently.
