4936 Agenda item 1:- Apologies for absence

4938 Agenda item 3:- To receive and adopt the minutes from the Ordinary meeting, held on 31 March 2021

parcel of land close to the above location. After some discussion it was agreed the Clerk should arrange for signs to be installed. After some debate it was:

Proposed: By Cllr Jones, seconded by Cllr Tilley the Community Council Clerk obtains the relevant signs.

4941 Agenda item 6:- To consider purchasing replacement benches for the community.

The Clerk explained that he submitted a report to the last meeting, and he is looking for a resolution to issue a purchase order for the benches. A discussion took place with a range of views being expressed by members. After some debate it was:

Proposed: By Cllr Moorby seconded by Cllr Leacock the Clerk orders two benches replacing the two benches located at Crown Square in Raglan and one VE Day bench to replace the bench outside the Church and provide the same bench for the Village Hall in Llandenny
