There was some discussion about the current situation in the Llandenny area, where some households have removed cables as no connections were installed due to infrastructure issues.

There was some discussion over the installation of poles and cables when residents were not notified and just found that some areas saw poles installed without consultation.

There was wider discussion about the installation and the ongoing works.
